# Mobile Phones, Electronic Devices, Facebook and Other Social Networking Sites

Can I urge once again all parents to be vigilant about their sons/daughters use of social networking sites such as Facebook. Used correctly and sensibly it can be a good way of communication. Unfortunately we are increasingly dealing with matters where it is being misused. We need to emphasise once again that students who use the sites to bully, harass, abuse, belittle or spread malicious rumours are in breach of the school's rules and may in fact be breaking the law. Students who are involved in such behaviours will be subject to the school's discipline code, including suspension, and we have no hesitation in referring serious matters to the police and this has already occurred.

Included in this newsletter is a copy of a new draft policy relating to mobile phones and electronic devices which the school has circulated for discussion. We ask parents to read it carefully and please feel free to make comments and or suggestions about this proposed policy. ### **Finley High School Charter - DRAFT**

#### **Our vision**

A vibrant school community that has learning as its key focus, that works co-operatively, that maximises the experiences, opportunities and outcomes of all students, in a safe and positive environment

### **Our student rules**

In regard to Respect, tolerance and care, students will understand that -

Verbal abuse, physical violence and vandalism will not be tolerated Bullying and harassment (including via new technologies) will not be tolerated

In regard to Responsibility and co-operation students will understand that they -

Must follow all staff instructions and classroom rules

Must act in a safe and responsible manner at all times

Must wear full school uniform at all times

Are never to bring to school illegal substances or any weapon

In regard to Learning and personal excellence students will understand that they -

Must bring all the necessary books and equipment needed to each class

Allow others to learn without interruption

Come to school with the full intention of learning, and complete all tasks and activities to the best of their abilities

### Our expectations of staff and parents

- All staff are expected to be supportive of all students, and to provide learning programs and experiences that are engaging, diverse, meaningful, and to challenge and assist students to produce their best
- All staff are expected to be learners and to continually strive to develop and enhance their teaching skills and knowledge
- All parents and caregivers are requested to give full support to students and the school as far as is possible, to support maximizing learning outcomes for all students

### PERSONAL ELECTRONIC DEVICES CHARTER - FINLEY HIGH SCHOOL -DRAFT

Students are strongly encouraged **not** to bring mobile phones, ipods, MP3 players or other electronic devices to school. They are expensive and can be easily lost, damaged or stolen. While the school does not encourage students to bring mobile phones to school, it is acknowledged that these devices may be important for student safety. Students and parents should understand that the following points also relate to other devices (such as ipods, MP3 players and other portable electronic devices) which some students bring to school.

- 1. <u>Bringing personal electronic devices to school is a privilege, not a right</u>. These devices must be used in a respectful, responsible and appropriate manner, especially in relation to the rights of others.
- 2. <u>Students bring personal electronic devices to school at their own risk</u> and should always ensure that the devices are secure. The school accepts no responsibility or liability for the damage or loss of such devices
  - If a device goes missing, the student should report the matter to a teacher and/or to the Deputy Principal. While every reasonable effort will be made to investigate, recovery is not always possible.
  - Nevertheless, any student who is found to be involved in the theft or illegal purchase of personal electronic devices at school may be suspended from school and the police contacted.
- 3. Mobile phones and other devices must be turned off during all school activities, classes (including Sport and PE), meetings, assemblies, performances, and whilst students are on detentions or on in school suspension, or when they are reporting to staff. Student learning and school activities must not be disrupted.
  - Improper use will result in the device being confiscated by teachers and handed to the Deputy Principal
  - Depending on circumstances it may be returned at end of the school day, or return may only be possible after contact with a parent or guardian
  - Repeat offences may mean that the student is not permitted to have such a device at school at all, or a student may face suspension for continued disobedience.
  - Student should not lend such devices to other students. In the event that a device is borrowed, if it is misused, the device and user, will still be subject to confiscation and other points as explained above.
- 4. <u>Students are not permitted to have mobile phones or other electronic devices in examinations or formal assessments</u>. Students who use such devices to cheat or gain an unfair advantage will be penalised.
- 5. <u>Mobile phones must not be used to by-pass school procedures</u> in relation to school-parent contact such as the notification of student illness, disciplinary procedures, or other emergency contact.
  - In emergencies, students or parents should contact the school office and arrangements will be made to inform the student or parents.
  - If a student is ill or injured at school, they must report to the school office and parents will be officially contacted if necessary. Students must not phone parents directly for permission to go home because they are sick the school's 'duty-of-care' obligations and procedures must be followed.
  - Students must not text or phone parents in regard to a discipline matter or personal matter prior to that
    matter being discussed with the Deputy Principal or Principal. This is to ensure that the school has
    knowledge of any such incident, and the opportunity to address any pressing matter, and deal with it
    promptly. The school will contact parents immediately where it is deemed appropriate.
- 6. Personal electronic devices must not be used to invade the privacy of others or breach the law.
  - "Cyber-bullying" is completely unacceptable and is against the law. <u>Students who use a personal electronic device</u>, including accessing social networking sites, in any manner to bully, harass, threaten, abuse, vilify or <u>embarrass other students or staff will face immediate disciplinary action</u>, which may include suspension from school and contact with the police if necessary.
  - Students must not photograph, video or record the images or voices of students or staff at any time without their specific permission.

- Where students do photograph, video or record the images or voices of students with their permission if such recordings are altered, enhanced or used in any way to bully, harass, threaten, vilify, embarrass or improperly represent others, the offending student(s) will face disciplinary action, which may include suspension from school and contact with the police if necessary.
- Students who receive unacceptable or inappropriate phone calls, text messages, or other material on their mobile phones at school should immediately inform a teacher and/or the Deputy Principal.

Parents are asked to discuss with their son/daughter not only this policy but also the ethical and appropriate use of all forms of modern information and communication technology.
